| March 9 | Candidate statements for President and Vice President will be sent via email to all members and posted on UF NOCCCD website (ufnorthorange.com). |
| March 15 | Ballot instructions sent via email from third party vendor, Simply Voting. Please check your spam/junk folders if you do not receive an email. If you do not find the email, please contact the Elections Chair at jwalkeruf@gmail.com . |
| March 15-19 | Voting via electronic platform beginning at 8am on March 15 and concluding at noon on March 19. |
| March 19 | The Elections Committee will download results from Simply Voting. A Teller's Report will be completed and results will be delivered to the President and members via email. Results will be posted on the UF NOCCCD website (ufnorthorange.com) by March 22. If a run-off election is necessary, this will be included in the announcement. |
| April 3 | A challenge to the election must be received by the Elections Chair (jwalkeruf@gmail.com) no later than 5pm unless there is a run-off election. |
| April 5 | Ballot instructions for run off, if necessary, sent via email from third party vendor, Simply Voting. Please check your spam/junk folders if you do not receive an email. If you do not find the email, please contact the Elections Chair at jwalkeruf@gmail.com . |
| April 5-9 | Voting for run-off election, if necessary, via electronic platform beginning at 8am April 5 and concluding at noon April 9. |
| April 9 | The Elections Committee will download results of run-off election from Simply Voting. A Teller's Report will be completed and results will be delivered to the President and members via email. Results, if necessary, will be posted on the UF NOCCCD website (ufnorthorange.com) by April 29. |
| April 24 | If a run-off election was necessary, a challenge to the election, including the run-off election, must be received electronically by the Elections Chair (jwalkeruf@gmail.com) no later than 5pm. |
