- March 13                    Announcement of vacancy via email to all members and posted on UF NOCCCD website (ufnorthorange.com).
- March 27                    Declarations of candidacy must be sent to Elections Committee Chair.
- March 28                    Acknowledgement of declarations of candidacy, distribute elections guidelines/rules for campaigning sent to candidates electronically from Elections Committee Chair.
- March 30                    Deadline for candidates to submit a statement to Elections Committee Chair. Statement is limited to 30 words.
- March 31                    Candidate statements will be sent via email to all members and posted on UF NOCCCD website (ufnorthorange.com).  
Deadline to request a paper ballot. Paper ballots can be sent to any Member who does not wish to vote electronically. A written request must be sent to the Elections Committee Chair. Paper ballots will be mailed to the last known address on file with CTA.
- April 3                      Paper ballots will be mailed to those members who requested.  
Deadline to inform Elections Committee Chair if candidate or designee will be observing counting of paper ballots, if any.
- April 6                      Voter credentials sent via email mail from third party vendor, Simply Voting. Please check your spam/junk folders if you do not receive an email. If you do not find the email, please contact the Elections Chair at [jwalkeruf@gmail.com](mailto:jwalkeruf@gmail.com).
- April 6-13                    Voting via electronic platform beginning at 8am on April 6 and concluding at 12pm on April 13. Paper ballots must be received at the UF PO Box by 12pm on April 13 (postmarked date not accepted).
- April 13                      The Elections Committee will download results from Simply Voting, count any paper ballots received and prepare a Teller's Report. Results to leadership and candidates.  
Results will be emailed to members and posted on the UF NOCCCD website (ufnorthorange.com) by April 14. If a run-off election is necessary, this will be included in the announcement.
- April 16                      Deadline to request a paper ballot for run off, if necessary. Paper ballots will be mailed to the last known address on file with CTA.
- April 23                      Any challenge to the election must be received by the Elections Chair ([jwalkeruf@gmail.com](mailto:jwalkeruf@gmail.com)) no later than 6pm unless there is a run-off election.
- April 17                      Paper ballots for run-off, if necessary, will be mailed to members who requested.  
Deadline to inform Elections Committee Chair if candidate or designee will be observing counting of paper ballots, if any.

- April 20 Voter credentials for run off, if necessary, sent via email from third party vendor, Simply Voting. Please check your spam/junk folders if you do not receive an email. If you do not find the email, please contact the Elections Chair at [jwalkeruf@gmail.com](mailto:jwalkeruf@gmail.com).
- April 20-27 Voting for run-off election, if necessary, via Simply Voting beginning at 8am April 20 and concluding at 12pm April 27. Paper ballots must be received at the UF PO Box by 12pm April 27 (postmarked date not accepted).
- April 27 The Elections Committee will download results from Simply Voting, count any paper ballots received and prepare a Teller's Report. Results to leadership and candidates.  
Results will be emailed to members and posted on the UF NOCCCD website ([ufnorthorange.com](http://ufnorthorange.com)) by April 28.
- May 8 If a run-off election was necessary, a challenge to the election, including the run-off election, must be received electronically by the Elections Chair ([jwalkeruf@gmail.com](mailto:jwalkeruf@gmail.com)) no later than 6pm.
