April 11 Candidate statements will be sent via email to all members and

posted on UF NOCCCD website (ufnorthorange.com). Paper ballots will be mailed to those members who requested. Deadline to inform Elections Committee Chair if candidate or designee will be observing counting of paper

ballots, if any.

April 15-24 Voting via electronic platform beginning at 8am on April 15 and

concluding at 12pm on April 24. Paper ballots must be received at the UF PO Box by 12pm on April 24 (postmarked date not accepted). Please check your spam/junk folders if you do not receive an email. If you do not find the email,

observing counting of paper ballots, if any.

April 29-May 8 Voting for run-off election, if necessary, via Simply Voting beginning at 8am
