- I. Quorum—Call to Order, 3:02pm
- II. Public commentary:
  - UF Treasurer commended President Diep and the Negotiations committee for their diligent work, and announced that all budgets are in order.
  - 2. Several concerns about lack of administrative support regarding urgent issues such as safety.
- III. Agenda: On motions duly made and carried (Delshad/Pashaie), the agenda was approved with one minor change.
- IV. Minutes: On motions duly made and carried (Delshad/Pashaie), the draft minutes for May 13, 2020 were approved.
- V. Treasurer's Report: Per CTA, UF does not post its budgets online, but current members may request a copy of the budget if they wish.
- VI. President's Report: Importance of the Faculty Contract as one of UF's prime directives. The contract is available online at the NOCCCD HR site, but members are legally permitted to receive a print copy if they wish by contacting their reps who will relay the information to council.
- VII. Grievance Report: Grievance officers Borla and Sampson reported up-to-date information on the many issues and problems they're currently engaged in.
- VIII. Negotiations Report: Up-to-date information was presented regarding the current state of negotiations as well as the processes and timelines for future course of action, including fact-finding. Member engagement is at an all-time high, with 95% and 90% ratification of the two recent MOUs.
- IX. Liaison/Committee/Committee Chair Approvals:
  - On motions duly made and carried (Delshad/Pashaie), Fola Odebunmi was appointed as the UF Liaison on the Black Lives Matter (BLM) Oversight Taskforce.
  - 2. On motions duly made and carried (Delshad/Pashaie), creation of the UF Racial Justice and Equity Committee (RJEC) was approved.
  - 3. On motions duly made and carried (Delshad/Pashaie), Ziza Delgado was appointed as the RJEC Chair.
