Call to Order [Diep]

UF President Christie Diep called the meeting to order at 3:04pm.

Treasurer's Report [Peterson]

Peterson shared an updated budget, documenting current savings and expenses. United Faculty's miscellaneous costs have decreased significantly, but due to the previous raises on overload, reassigned time costs have increased. It was M/S/P (Peterson/Rosen) to approve the UF budget for 2024-2025.

2024/2025 Representative Council Meeting Dates [Diep]

President's Report [Diep]

Diep shared an extensive update on negotiations during the President's Report. United Faculty shared a proposal with the District in November and December of 2023, and the District refused to provide United Faculty with financials until May 2024. The District's counteroffer included a miserly 1.4% raise for 2024/2025 and 0% for the following two years, an Orwellian time clock system to monitor asynchronous classes, and a refusal to adequately increase benefits and overload pay.

Given how far apart United Faculty and the District are in their proposals, it appears that impasse is likely. Peters shared a general timeline of what to expect if the District does not present a realistic offer by May 17, 2024.
